

The Leadership team includes the principal, two coaches, a family member, a family support specialist, and a teacher.

The team's review of the program's BIR data indicated an equity alert based on out-of-school suspensions. Their review of the Out-of-School Suspension Events Profile identified that three African American children were suspended for a total of four out-of-school suspension events.

They also reviewed the EC-PWBOQ to identify whether the benchmarks that were not in place or partially in place might relate to cultural responsiveness and the issue of equity. They were especially concerned with how they engaged families and procedures for responding to challenging behavior.

Review the BIR data and the EC-PWBOQ.

Is this a system issue?

What factors might they consider from the data they have?

What additional data might they want?

What would be their next steps?

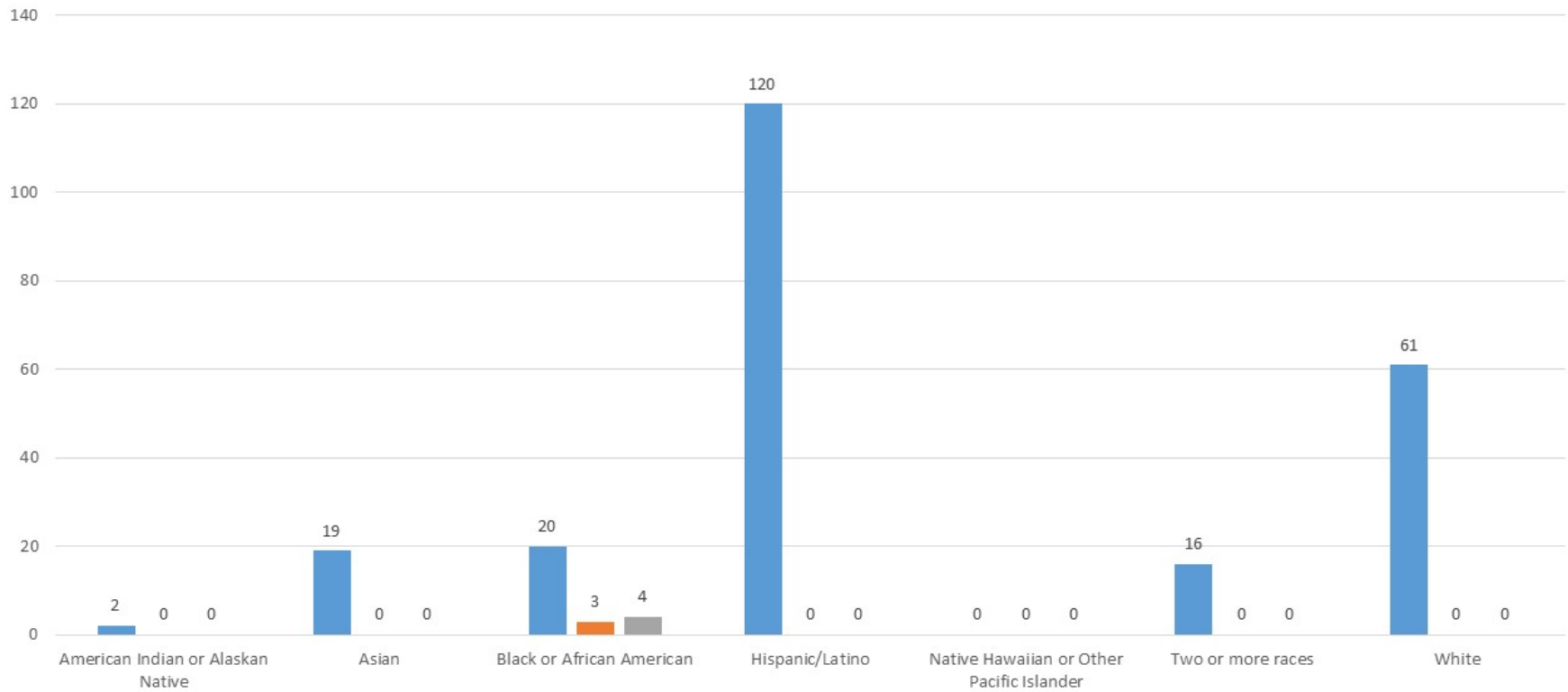

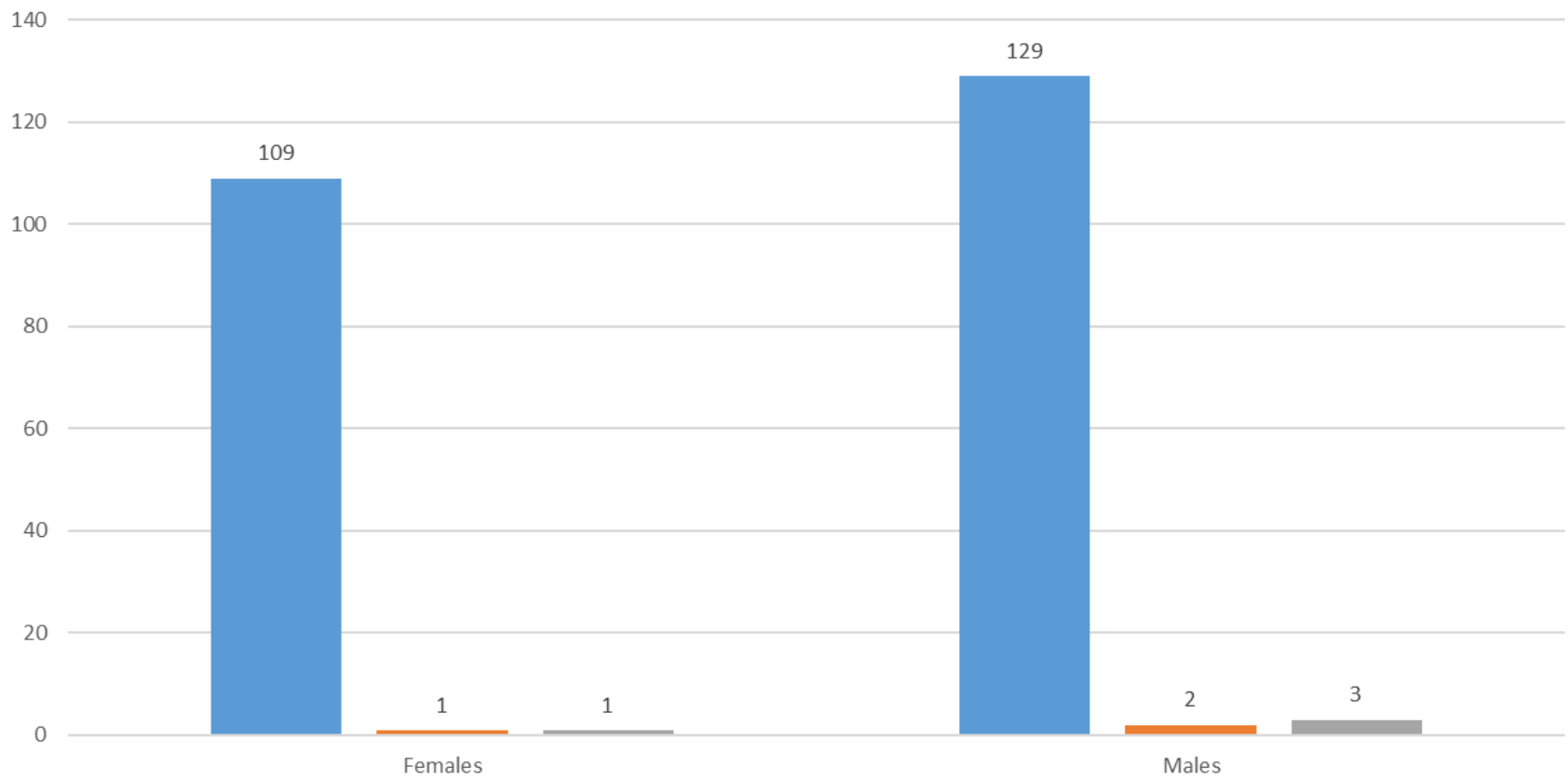
Out-of-School Suspensions by Race/Ethnicity
