

Historically, in RI....

Engage Stakeholders to:

- Focus on front line staff of ECE programs to get LTSAE materials into the hands of families
- Train and support front line staff on how to coach families on the use of LTSAE materials
- Use LTSAE materials to help facilitate and support universal screening

As a result, we hope that:

- Families will know how to track their child's development
- Families will feel empowered to advocate for their child when they suspect their child may be experiencing a developmental delay.
- Children are identified earlier and families can access services quickly
- Families will provide input on the use and usefulness of LTSAE materials


