Sustainability and Scale-up Planning Steps

1. Confirm Vision
2. Backward Map: How do we reach our vision? (timelines, sustaining high fidelity, scaling up)
3. Review BoQ ratings and action plan
4. Involve demonstration programs' Leadership Teams and Program Coaches in planning for sustainability and scale-up
5. Complete the Sustainability and Scale-up Planning Matrix (below); review all the BoQ items related to sustainability and scale-up noted by each item of the Matrix
6. Action planning (add sustainability and scale-up actions, timelines and resources to action plan)

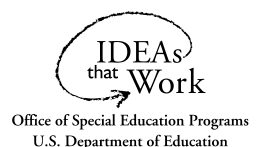
